Stake N Bud (\$BUD) introduces a comprehensive approach to token distribution, staking rewards, and liquidity management.

By carefully planning the token supply, incentivizing staking, and ensuring a gradual increase in liquidity through an innovative unlocking and liquidity addition schedule, \$BUD aims to create a sustainable and attractive ecosystem for its users.

The strategic use of transaction taxes to fund liquidity additions further integrates the project's activities with its market performance, aligning the interests of holders, stakers, and traders alike.

Tokenomics

Total Supply: 1 billion \$BUD tokens

- **Trading Liquidity:**

20% of the total supply, which equals 200 million \$BUD tokens, will be made available for trading. These tokens will be paired with BNB to provide liquidity on decentralized exchanges (DEXs), facilitating easy buying and selling of \$BUD tokens.

- **Staking Contract:**

40% of the total supply, amounting to 400 million \$BUD tokens, will be allocated to a staking contract. Users can stake their \$BUD tokens in this contract to receive additional tokens as rewards, encouraging long-term holding and participation in the ecosystem.

- **Locked Tokens:**

The remaining 40% of the total supply, also 400 million \$BUD tokens, will initially be locked. These locked tokens are set to unlock in predetermined portions at specific times, strategically increasing the circulating supply and using a portion of these unlocked tokens along with BNB collected from transaction taxes to add more liquidity to the market.

Unlocking Schedule and Liquidity Addition

The locked portion of \$BUD tokens will unlock according to the following schedule:

- 15% (60 million \$BUD tokens) unlock 24 hours after the initial locking period.
- 10% (40 million \$BUD tokens) unlock 72 hours after the initial lock.
- 5% (20 million \$BUD tokens) unlock 1 week after the initial lock.
- 1% (8 million \$BUD tokens) weekly thereafter until all the locked tokens are released.

Taxation Structure, Benefits, and Contract Renouncement

Initial Phase: Launch Tax Structure

- **Total Tax: 10%**
 - **Marketing: 5%** - A significant portion is dedicated to marketing to ensure effective promotion, reach potential investors, and foster growth.
 - **Auto-Liquidity: 5%** - Equally important, this allocation supports a stable market for our token, ensuring smooth transactions and price stability.

Intermediate Phase: Adjusted Tax Structure

24 HOURS After Launch, we transition to a more diversified tax allocation:

- **Total Tax: 10%**
 - **Marketing: 4%** - Slightly reduced to reallocate resources while still prioritizing growth and engagement.
 - **Liquidity: 4%** - Maintaining a strong liquidity pool to ensure market stability.
 - **USDT Rewards: 2%** - Introducing rewards to give back to our community, encouraging long-term holding.

Final Adjustment: Reduced Tax and Contract Renouncement

As we enter a phase focused on sustainability and long-term value:

- **Total Tax: 5%**
 - **Marketing: 2%** - Efficiently supporting continued engagement with a smaller allocation.
 - **Liquidity: 2%** - Ensuring the health of the liquidity pool remains a priority.
 - **USDT Rewards: 1%** - Continuing to reward our community, reinforcing the benefits of holding our token.

Contract Renouncement Commitment

Upon reaching this final tax structure, we will take a significant step to further secure our project's integrity and trustworthiness: **renouncing ownership of the contract**. This action is a testament to our commitment to the project's future and our community's welfare. Renouncing the contract means that no one will have the authority to make changes to the token's contract, ensuring its immutability and protecting it against potential vulnerabilities or manipulation.
